RevSport

Motion: SACA to provide clubs with a comprehensive report containing information about RevSport. Proposed by: Marianne Maycock. Seconded: Mark Goldsmith. Voted. Carried.

Amendment: Individual players should also be sent a comprehensive report containing information about RevSport.

Proposed by: Roger Buddle. Seconded: Janet Wilshire. Voted. Carried.

Motion: Once the RevSport report has been distributed to both clubs and individual players, clubs will be given the opportunity to collect questions from their members. These questions should then be submitted to SACA, who will compile them and seek responses from the relevant sources.

Proposed by: Alexandra James. Seconded: Kim Millhouse. Voted. Carried.

Questions invited. Questions asked.

- Can you re-register multiple club players at one time?
- Why should clubs have to pay additional fees to have access and use of RevSport and also pay SACA fees at the current level?
- How will clubs that have little to no computer literacy be able to successfully implement RevSport into their club?
- Why should club fees be paid into RevSport?
- Can a club choose not to integrate RevSport into its membership management?
- What rate will clubs be paying for RevSport after the subsidised rate expires after three years?
- How secure is data stored within RevSport?

Insurance policy. The insurance policy has been updated as of the 1st of January and certificates have been issued to clubs.

Grant Application. The grant application for funds to subsidise the wage of the administration officer was rejected because the details didn't contain 40% female representation. An appeal has been submitted by saying Lorraine was still on the board at that stage and Eileen had only just withdrawn because of neck fusion. We hope for a positive result.

Drainage at Hutt Rd and Adelaide City Council. No progress regarding improving the drainage at Hutt Rd. Carparking is an ongoing request.

Decreased participation. Concern regarding the number of teams that are entering competitions.
